CISU AS A CONNECTOR OF LEARNING AND NETWORKS

Ongoing learning and collaboration is key to greater impact.

- » CISU will connect civil society to exchange experiences and knowledge and build bridges to private sector, knowledge institutions, and other sectors of society.
- » CISU will establish learning mechanisms that allows us to learn from members, partners and global trends, analyse and condense this learning and share it in member base, the partnerships and with global stakeholders
- » CISU will enhance representation and accessibility of the entire partnership in our activities.

CISU AS AN ACKNOWLEDGED AND VISIBLE ACTOR IN DENMARK

Recognition, acknowledgement and visibility is essential to stronger civil societies in Denmark and globally.

- » CISU will foster a community of actors that engages the broad public in Denmark on global issues.
- » CISU will use our collective power to advocate for necessary changes in the enabling environment that supports a strong, diverse, globally connected civil society.
- » CISU will speak up in alliance with civil society across the world in defense of civic space.

CISU AS A CHAMPION OF REIMAGINING PARTNERSHIPS

CISUs privileged position obliges us to be ambitious in partnership and funding mechanisms to support locally led development.

- » CISU will further develop on how the partnerships can best make use of the added value of each partner's contributions.
- » CISU will ensure that funding for engagement of the broad public in Denmark facilitates global equity, and a strengthened role for Danish civil society to mobilize for global solidarity
- » CISU will stimulate new funding approaches of partnerships and funding supports local decision making and co-creation.

Context for priorities

CISU wants to be a connector of learning and networks because:

Globally, civil society, freedom, democracy and human rights are under attack.

However, all around the world capable civil societies are flourishing and finding new ways and directions.

Civil societies that are much stronger on analysis, mobilisation, action, voice, and new modes of operation and organisation.

The future strong alliances between civil society will be driven by global south forces.

Innovation and locally led initiatives will increase in magnitude, quality and scale.

The potential of future global civil societies demands joint learning on how to boost initiative, organisation, resilience, representation and accountability and build strong civil societies.

CISU wants to be an acknowledged and visible actor in Denmark because:

Civil society in Denmark involved in global issues have increased, in numbers and in diversity.

New organisations, diasporas and new groups in society develop new approaches to a globally connected civil society.

At the same time, the political framework for civil society via official strategies is less clear. Structures for civil society influencing on Danish development policy is diminishing.

There is an increasing pressure in Denmark also on which type of civil society that can operate on which issues. This undermines the popular support for CISU member organisations and on development cooperation at large.

The increase of Danish actors involved in engaging the public in Denmark on global issues however tell a different story of a more globally engaged Danish society. There is rich potential in harnessing this.

Civil societies globally and in Denmark play crucial roles in facilitating just and fair societies. This collaboration has been taking place for decades, but this joint work of globally connected civil society is now more needed than ever.

Civil society is in a position where we have to fight for support and legitimacy around our cause, and the work that we do. While many of our allies are strong in their locality, the collective power behind CISU can play a strong role influencing the Danish society.

CISU wants to be a champion of reimagining partnerships because:

Development funding is decreasing globally. Global challenges are on the increase. Potential global threats need to be invested in to be dealt with.

CISU believes in the power of people to organise around the issues that affect them. Solutions are often most sustainable when locally anchored.

CISUs fund modalities are under pressure due to decreasing global funding and active civil societies in Denmark and internationally. The task at hand is to focus on what enables an independent, diverse and globally connected civil society that can address the global challenges.

Global civil society voices are leading an effort to reimagine the "aid sector" and replace it with a more fit-for-purpose interconnectedness of actors and funding streams

CISU operates with a high level of trust in our systems, both from main donors and internally from grant holders.

Member organisations and partnerships have proven approaches where locally led development and partnerships across borders are not opposites but rather are seen as mutually benefitting forces.

At the same time, the current setup of partnerships is also being contested as a hindrance to reforming away from a colonial aid sector.

Time is ripe for testing new funding streams, and in new setups strengthen the roles of both Danish civil society actors and the global partners they work with.

CISU works with capacity development, networking, framework conditions and knowledge sharing to ensure that CISU's member organisations remain relevant and ambitious partners in global partnerships.




In Denmark, CISU and its member organisations work to raise awareness of global issues and engage the public in a shared world.

Democracy, human rights and the civic space are under pressure in many parts of the world due to a shift towards autocracy, arbitrariness and the suppression of rights.


The planet, its animals, plants and people are being affected
