**Country and location(s):** The Gaza Strip and the West Bank.

**DERF Funding Modality:** Applicants are to apply for the DERF Funding Modality *Rapid Response* as per the DERF Funding Guidelines.

**Call window for submission of applications:** Applications are received and processed on an ongoing basis from 27-3-2025 until 30-4-2025 at 12:00 noon CET. Please note that the DERF office will be closed from 12 to 21 April and will reopen on 22 April. During this period, applications will not be processed.

Funds allocated for this Call: The DERF allocates a total of up to DKK 4 million for this Call. Applicants can apply for maximum DKK 1 million each.

**Piloting flexible funds and 5% local administration**: Under this call, you may (optional) include 10% of *flexible funds* for activities. Furthermore, *local partner administration* is now a lumpsum of up to 5% of total partner costs. Please read carefully all the details about this pilot in the following <u>Guiding Note</u>.

**West Bank:** Military operations in the northern West Bank continue to cause casualties, destruction and displacement. Between 11 and 17 March, five Palestinians were killed, and 82 were injured across the West Bank, including East Jerusalem. (UN-OCHA)

**Prioritised Emergency Actions**: There is an urgent need for emergency interventions. The key humanitarian priorities identified include, but are not limited to:

- Protection and psychosocial support for vulnerable people and restoring family links.
- Food Security and Livelihoods FSL, e.g., through Cash Based Assistance (CBA)
- WASH (access to clean water and storage containers, hygiene and sanitation)
- Health (access to medical care and emergency health services)
- Emergency shelter (tents, as well as medium-term solutions to withstand winter) and Non-Food Items - NFIs (tarpaulins, blankets, mattresses, clothes, and kitchen sets etc.)

The types of needs in the West Bank are similar to those in the Gaza Strip, though their scale is significantly greater in the Gaza Strip. Civil society actors are encouraged to assess the space available for humanitarian action and prioritise efforts where they can have the greatest impact, while taking into account and addressing the access and security challenges outlined below.

**Vulnerability:** All people in Gaza are experiencing extreme vulnerability and are in urgent need of humanitarian assistance. In the West Bank, vulnerable groups include internally displaced persons (IDPs), women, children, the elderly, and persons with disabilities.

**Funding Situation**: As of 20 March 2025, UN Member States have disbursed approximately US\$175.6 million out of the \$4.07 billion (4.3 per cent) requested to meet the most critical humanitarian needs of three million out of 3.3 million people identified as requiring assistance in Gaza and the West Bank, including East Jerusalem. During February 2025, the oPt Humanitarian Fund (oPt HF) managed 87 ongoing projects, totalling \$62.6 million, to address urgent needs in the Gaza Strip (86 per cent) and the West Bank (14 per cent) (UN-OCHA).

**Humanitarian Access:** Since 2 March, the Israeli government has banned the entry of humanitarian aid and any other supplies via all land crossings into Gaza – the longest such closure since October 2023. Gains made during the ceasefire to support survivors have been reversed. (UN-OCHA). Therefore, humanitarian efforts are crippled as the ban by authorities on the entry of any supplies has now entered its fourth week. Although access to Gaza remains severely restricted and the security situation is highly volatile, several humanitarian actors are currently operating in the area and stand ready to deliver and scale up life-saving assistance when conditions allow. These actors include various UN agencies, the International Committee of the Red Cross (ICRC), the International Federation of Red Cross and Red Crescent Societies (IFRC), international organisations, and local NGOs.

DERF applicants must clearly and thoroughly describe how they plan to reach target groups within the chosen intervention areas and in relation to the planned activities. This information is a key part of the

assessment process and must be addressed in detail in the relevant sections of the DERF Rapid Response application format (sections 2.1a, b, or c).

Security: Humanitarian aid workers in the Gaza Strip face a significant risk of injury or loss of life.
Between 18 and 25 March, at least eight aid workers were killed, and two humanitarian facilities were hit in Gaza. In total, since 7 October 2023, at least 399 aid workers, including 289 UN staff, 34 Palestine Red Crescent Society (PRCS) staff and at least 76 other NGO staff have been killed in Gaza. (UN-OCHA). When planning and budgeting, applicants should carefully consider the physical and digital security of both implementing partners and target groups. Regarding anti-terror regulations, DERF applicants are required to take all necessary precautions to ensure that no transaction related to the intervention—whether directly or indirectly—benefits any individual, group, or entity subject to UN or EU sanctions. All applicants must ensure that their humanitarian interventions are guided by the principles of neutrality and impartiality. Assistance should be provided solely based on needs, without discrimination, and without taking sides in political, religious, or military conflicts.
