In Galmudug, moderate rains led to a rise in waterborne diseases like acute watery diarrhoea and cholera. Jubaland also reported damage to shelters, affecting thousands of households, with many seeking refuge in host communities. In South West State, the Shabelle River's rising levels pose a severe risk of riverine flooding, already affecting 273 households, with additional impacts on displaced persons in Baidoa. (OCHA, May 20) Prioritized Emergency Actions Authorities and communities in affected areas are appealing for urgent multi-sectoral assistance including food, water, shelter, non-food items, and water, sanitation and hygiene (WASH) supplies.
